As per the direction of President, Medical Assessment and Rating Board for Indian System of Medicine (NCISM), the assessment report was placed in the 82<sup>nd</sup> Board meeting of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) held on 08.03.2024 and Board concluded that the college is not fulfilling the notified & approved criteria, but fulfilling the criteria required for issuance of conditional permission as mentioned in Regulation 3 and as per the note mentioned in Schedule-VI and IV of MSR 2016. Hence, Board decided to issue the Conditional permission with 60 seats (75 seats including EWS) in UG (BAMS) course and 16 Seats in 05 PG Courses in the subjects namely (i) Kayachikitsa 03 Seats (ii) Shalya Tantra 03 Seats (iii) Rachna Sharir 02 Seats (iv) Ayurveda Samhita Siddhanta 02 Seats (v) Rog Nidan ayum Vikriti Vigyan 06 Seats under section 28 of NCISM Act, 2020 for the academic session 2024-25.
- 4. Therefore, conditional permission is granted to Shri Radhakisan Toshniwal Ayurved Mahavidyalaya, Kediya Plots, Jathur Peth Road, Dist. Akola-444005, Maharashtra (Inst. The counseling for seats under all India quota shall be conducted by respective counseling authority as designated by Central Government for AY. 2024-25 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT.
