4. The colleges shall obtain continuation of affiliation every year before the commencement of admission process.
5. In case of disaffiliation with the present university, the existing batches shall continue with the present university till award of degree for the last student.
6. The consent of continuation/ extension of affiliation is issued subject to rectification of following deficiencies by the college and submission of compliance report **within 30 days.**
